Why We Have Covenants

Covenants are put in place to protect the value of homes in areas that are not within city limits. Most of the Lakewood Villages covenants are required by the City of Bellevue, which has zoning jurisdiction over all land in Lakewood Villages.

If you haven't reviewed the covenants you received when you purchased your home, there's no time like the present. All covenants are available for review at the LVNA Web site. Home sellers are required by law to provide a copy of the covenants to each buyer, who signs a declaration at closing stating that he or she has received a copy.

Covenants are legally binding and homeowners in violation may be sued by other homeowners if necessary to maintain the integrity of the neighborhood.

SID Elections Take Place in August

All of Lakewood Villages, including the businesses that front Highway 370, are part of Sanitary and Improvement District 180, Nebraska's form of municipal government for developments outside city limits. The SID provides services such as street lights, storm sewers and street repair and pays for them by collecting property taxes. Once the area is annexed by Bellevue, the SID will be terminated.

The SID's governing body is a board of volunteer trustees elected by the residents every two years. Residents interested in running for the board can register at the Sarpy County Election Commission in the Court House Annex in Papillion.

Contact information for the SID board and its consultants is available on the LVNA Web site.

The SID board of trustees usually meets once a month at the NP Dodge Real Estate office building at 48th & Shannon Drive. Meeting notices are currently posted in the Bellevue Leader, on the LVNA Web site and on <u>www.lakewoodVillages.com</u>. Residents are welcome at all meetings.

Residents who have requests or business to put before the SID Board must submit them in writing (e-mail is accepted) to the SID attorney's office.

Report from the SID Board

The SID board has continued to examine all expenses carefully to prevent raising the tax levy if at all possible. Our extensive construction debt and the interest on those construction bonds will become a major portion of our budget as the bonds become due.

To this end the SID board continues to closely oversee many services.

• We have again contracted with Royal Lawns of Elkhorn to mow, maintain landscaped areas, empty trashcans and remove snow from sidewalk trail in winter. Mowing is more frequent in spring and fall, less frequent in summer when the grass does not grow as quickly. A limited number of street and curb repairs will be completed this summer. Contractors should begin the repair work in July. HGM, the SID engineering consultants, have identified areas to be considered for repair. If you want to know whether an area near your home is slated for repair, call

346-7559 and ask for Dave Harnish.

Who Maintains Trees?

The developer of Lakewood Villages, NP Dodge Land Development, planted a beautiful array of trees to line the entrance to our neighborhood. As a service to all residents, the SID pays for mulching and mowing on the entrance road to keep it looking its best. However, the SID is only responsible to remove or replace trees in the landscaped traffic islands, the park or on out lots. Trees that are located on homeowners' property are the responsibility of the homeowner. If you are uncertain of your property line, check the plot plan you received at closing.

Did You Know?

- Sidewalks, while public thoroughfares, are your responsibility. They cannot be blocked by parked automobiles, toys, skateboard ramps or garbage cans. Homeowners are required to maintain sidewalks, including snow removal in winter and gravel removal in the spring. Sarpy County sheriffs are happy to ticket those who do not.
- All front, side and rear yards must be sodded.
- A tree of no less than 2" in diameter must be planted in the front yard of each single-family home within one year.
- No out buildings are permitted.
- Trash containers kept outside the house must be screened from view. Air conditioning compressors may not be visible from the street.
- All fences, walls, patios, decks, gardens, swimming pools and flagpoles must be approved by the Architectural Control Committee, currently overseen by NP Dodge at 398-LAND.
- Extended vehicle maintenance is not permitted in driveways or in the street.
- Dog runs and chain link fences are prohibited.

95% of all covenant violations are satisfactorily resolved with a knock on your neighbor's door. Please do your part to make our neighborhood a respectable, friendly place to live.
